

# What is a Community Design Process?



## Community Meetings vs. Community Design Process

Community Meetings :

A gathering of a designated part of the community to discuss a certain topic to either build support or counter skepticism about a given topic.

Or a gathering in which, regardless of the reason for its convening, someone stands up to complain about something.







#### Community Meetings vs. Community Design Process

#### **Community Design Process:**

Is not a series of community meetings, it is a design approach that attempts to actively involve all stakeholders in the process, to create environments that are more responsive and appropriate to their inhabitants' and users' cultural, emotional, spiritual and practical needs.







#### "Design" Process:

The rules have to be clear, the community won't design the final project but has to be engaged at multiple stages to the help define the problem and to focus ideas for solution as well as to help evaluate proposed solutions.

the team has to be willing to abandon their preconceived notion of what the "right" thing to do is.

If we're there to just sell an idea, the audience will know, so be prepared for solutions coming out of left field and giving them a chance.







#### Be Honest:

Clearly outline what the challenges are. The Community is willing to compromise, but needs to understand both the costs and benefits of these decisions

Parking Question: If there are fewer parking spots what are the repercussions in the built environment? what will the neighborhood look like? what other benefits we will see?











