
Memorandum of Agreement (MOA) between EPA and FEMA

- Signed in 2010, grew out of collaboration between EPA & FEMA after floods in lowa in 2008.
- As part of FEMA's longterm recovery efforts, EPA provided assistance to 5 lowa communities on smart growth, green infrastructure, & green building.





Joint Projects



Smart Growth Implementation Assistance in Vermont

- Flooding & erosion from Tropical Storm Irene in August 2011.
- VT requested assistance in
 - helping communities become more resilient to future flooding.
 - assessing how state agency programs
 & policies help or hinder resilience.
- Partners: FEMA, state agencies, Mad River Valley Planning District, Friends of the Mad River, Central VT Regional Planning Commission.






Mad River Valley

We reviewed development regulations and plans to develop options for:

- 1. Protecting river corridors.
- 2. Developing in safer areas.
- 3. Protecting vulnerable settlements.
- 4. Managing stormwater.



Community Checklist

Example: Overall Strategies to Enhance Resilience

- Does the community comprehensive plan have a hazard element that includes flood planning or is addressed in another section of the plan?
- Does the community plan cross reference the local hazard mitigation plan (HMP) and any disaster recovery plans?
- Does the community plan identify flood-prone areas, including River Corridor/Fluvial Erosion Hazard areas, if applicable?
- Did the local government emergency response personnel, floodplain manager, or department of public works participate in the community plan process?......

Progress in the Mad River Valley

River Corridors: Warren passed Fluvial Erosion Hazard Zoning bylaws.

Vulnerable Settlements: Mad River stream bank stabilization project.

Safer Areas: Wastewater infrastructure funding in growth center.

Manage stormwater: Green infrastructure demonstration projects.





State Agency Progress

- The Agency of Natural Resources has hired two additional River Engineers.
- VTrans is surveying all 60,000 culverts on state roads to prioritize upgrades and working with Agency of Natural Resources on fish passage and erosion hazards.
- The Agency of Commerce & Community Development is including consideration of floodways when updating certain state designation programs, including Growth Center designations.
- The Division of Emergency Management and Homeland Security has hired additional staff to work on their FEMA-funded Public Assistance program.
