

PROJECT LOCATION



PROJECT BACKGROUND



- SC State Ports Authority (SCSPA) DEIS to build a \$700 million, 286-acre new port terminal and \$300 million port access road
 - Increase capacity by 1.4 million TEUs
 - At full build-out, the facility would have 3,500 ft. of berth, 13 cranes, 202 acres of container storage space
 - Only permitted new marine terminal construction project on the U.S. East Coast

SOCIAL IMPACT ASSESSMENT BASIS

National Environmental Policy Act (NEPA)

- ➤ When required by NEPA, Federal agencies must analyze the environmental, health, economic and social impacts of its activities on minority and low-income populations
- ➤ Each Federal agency shall provide opportunities for community input, including identifying potential impacts and mitigation measures

Executive Order #12898

Ensures that environmental justice populations are not exposed to unjustly high and adverse environmental impacts as a result of federal actions

SCSPA Conditional Permit

Corps issues conditional permit based on public comments that DEIS did not fully evaluate all environmental impacts



SOCIAL IMPACT ASSESSMENT METHODOLOGY

- Goal maximize positive community benefits and minimize negative environmental impacts
 - Commitment to go beyond traditional environmental mitigation and assess impacts to the "human environment"
- 2. Comprehensive review of Draft Environmental Impact Statement (DEIS)
- 3. Extensive community engagement and education program to identify social impacts and viable mitigation measures



SOCIAL IMPACT ASSESSMENT SNAPSHOT

Project Impacts	Direct, Indirect Cumulative and Social Impacts	Proposed Remedies
Property Acquisition and Rezoning	Tax and Property Value Losses	Establishment of an affordable housing trust to replenish housing stock with new, affordable, energy efficient housing
Environmental	Noise, CO ₂ and PM _{2.5} emissions, vibration, light pollution, truck traffic, train horns, etc.	Air and vibration monitoring, quiet zones, truck study, limited construction hours
Economic Development	Job and Business Opportunities	Development of a Maritime Training Institute, DBE/MBE assistance programs

COMMUNITY MITIGATION PLAN IMPLEMENTATION

- Tri-party agreements created between SCSPA, City and Community
 - Allows community fiduciary and administrative control
 - City of North Charleston provides project management and technical assistance
- Mitigation Agreement Commission established to oversee Community Mitigation Plan implementation
- Payment Schedule
 - ➤ Upon issuance of Federal and State permits for terminal construction \$750,000 paid to City c/o designated community group
 - Annual payments of \$300,000 during active construction of the project
 - Remaining balance will be paid upon new terminal dedication and opening



PROJECT OUTCOMES

- National, State and Local recognition
- Leveraged over \$3 million in matching grant funding
- Social impact assessment now serves as a model for all NEPA projects within the region
